

Sealed bid proposals will be publicly opened and read aloud on November 5, 2024 immediately following the bid deadline at the owner's address listed above by the Anchor Bay School District Maintenance Department.

2. The Owner shall not open, consider, or accept a bid proposal that is received after the date and time specified for bid submission in this advertisement for bids. Please note that some delivery services consider the Anchor Bay School District Maintenance Department a rural route. 
